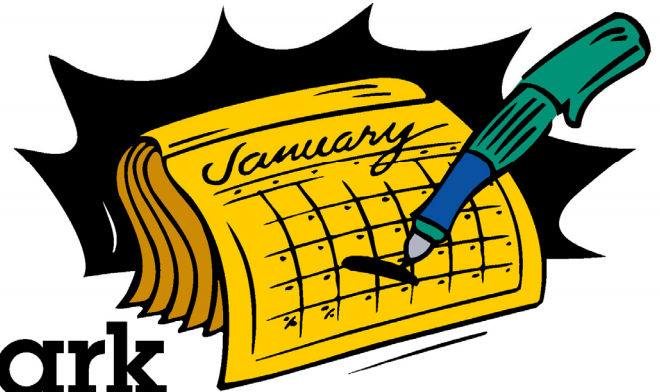


Updates on the latest news concerning SANC
